### **END-USER LICENSE AGREEMENT FOR ELUTIONS' SOFTWARE**

**IMPORTANT — READ CAREFULLY:** This Elutions End-User License Agreement (“EULA”) is a legal agreement between you (either an individual or a single entity) and Elutions B.V., with its registered office at Het Poortgebouw, Beech Avenue 54-62, 1119 PW Schiphol-Rijk, Nederland (“Elutions”) for the software product identified above, which includes the media on which you received it, updates (if any), associated printed materials, and may include Internet-based or electronic documentation (“Software”). Nothing other than this EULA grants you permission to use the Software. By installing, copying, or otherwise using the Software, you indicate your acceptance of this EULA and agree to be bound by the terms and conditions of this EULA. If you do not agree to the terms of this EULA, do not download, install, or use the Software, and promptly return the Software to Elutions at the address indicated below in Section 8.

## SOFTWARE LICENSE

The Software is protected by copyright laws and international copyright treaties. The Software is licensed, not sold.

1. **GRANT OF LICENSE.** This EULA grants you a limited, non-exclusive, revocable license. Unless applicable law gives you more rights despite this limitation, you may use the Software only as expressly permitted in this agreement. Elutions reserves all other rights. This EULA grants you the following rights:

**Systems Software.** You may install and use one copy of the Software on a single computer for one software file (an “Application”) only for use by one user. You may transfer this copy of the Software from one Application (the “Old Application”) to another Application (the “New Application”), provided that you uninstall and transfer all components of the Software from the Old Application and delete all files from the Old Application before using the Software for the New Application. You may not share this license between applications.

**Storage/Network Use.** A license for the Software may not be shared or used concurrently on different computers. If your Application involves networked computers, you must purchase a copy of the Software for each computer.

**Components and Modules.** The components of the Software are: (a) System CDs, (b) Documentation, and (c) a Hard Lock Module. Elutions supplies all software modules of the Software in the package for the Software. However, your license extends only to the modules that are enabled by the Hard Lock Module included in the Software. Other modules have limited functionality and may be used only for demonstration and evaluation purposes.

2. **UPGRADES.** If the Software is an upgrade/update, whether from Elutions or another supplier, you may use or transfer the Software only in conjunction with the upgraded/updated product. If the Software is an upgrade/update from an Elutions product, you may use that upgraded/updated product only in accordance with this EULA. If the Software is an upgrade/update of a component of a package of software programs that you licensed as a single product, the Software may be used and transferred only as part of that single product package and may not be separated for use on more than one computer. For the avoidance of doubt, this EULA does not entitle you to any support, upgrades, patches, enhancements, or fixes for the Software (collectively, “Support”) unless Support is arranged separately by you with Elutions and an appropriate agreement and payment of any fees associated therewith are agreed upon.

3. **COPYRIGHT.** All title and copyrights in and to the Software (including but not limited to any images, photographs, animations, video, audio, music, text, and “applets” incorporated into the Software), the accompanying printed materials, and any copies of the Software are owned by Elutions or its suppliers. The Software is protected by copyright laws and international treaty provisions. Therefore, you must treat the Software like any other copyrighted material except that you may make one copy of the Software (“Backup Copy”) on a single computer, provided that you use the Backup Copy solely for backup or archival purposes.

You may not copy the printed materials or documentation accompanying or comprising the Software, except as expressly set forth in this EULA.

4. DESCRIPTION OF OTHER RIGHTS AND LIMITATIONS.

Limitations on Reverse Engineering, Decompilation, and Disassembly. You may not (nor permit, cause, or enable any third party to) reverse engineer, decompile, or disassemble the Software, except and only to the extent that such activity is expressly permitted by applicable law notwithstanding this limitation. You may not open the Hard Lock Module or attempt to duplicate it in any way.

No Separation of Components. The Software is licensed as a single product and neither the software programs comprising the Software nor any update may be separated for use by more than one user or on more than one computer at a time.

Rental. You may not rent or lease the Software.

Termination. Without prejudice to any other rights, Elutions may terminate this EULA if you fail to comply with the terms and conditions of this EULA. In such event, you must destroy all copies of the Software.

5. DUAL-MEDIA SOFTWARE. You may receive the Software in more than one medium. Regardless of the type or size of the medium you receive, you may use only one medium that is appropriate for your single computer. You may not use or install the other medium on another computer. You may not loan, rent, lease, or otherwise transfer the other medium to another user.

6. U.S. GOVERNMENT RESTRICTED RIGHTS. The Software and documentation are provided with restricted rights. Use, duplication, or disclosure by the Government is subject to restriction as set forth in subparagraph (c)(1)(ii) of the Rights in Technical Data and Computer Software clause at DFARS 252.227-7013 or subparagraphs (c)(1) and (2) of the Commercial Computer Software-Restricted Rights at 48 CFR 52.227-19, as applicable. The manufacturer is Elutions SAS, with its registered address at Le Quatuor, 14 avenue Tony Garnier, 69007 Lyon, France.

7. GOVERNING LAW. This EULA is governed by the laws of England. Any enforcement proceeding related to this Agreement shall be brought in the courts of England provided, however, that either party shall be entitled to bring an action for emergency, injunctive or interlocutory relief in any forum having jurisdiction.

8. NOTICES. If you have a notice, request, instruction or other document or mailing to be given under this EULA, mail it to Elutions SAS, Le Quatuor, 14 avenue Tony Garnier, 69007 Lyon, France.

9. LIMITED WARRANTY. Elutions warrants that the System CDs and Hard Lock Module included in the Software will be free from defects in materials and workmanship under normal use and service for a period of ninety (90) days from the date of receipt ("Limited Warranty"). If an implied warranty or condition is created

by your state or jurisdiction and disclaimer of the implied warranty is prohibited, you also have an implied warranty or condition, but only as to defects discovered during the period of this Limited Warranty (ninety-days). As to any defects discovered after the ninety-day period, there is no warranty or condition of any kind. Some jurisdictions do not allow limitations on how long an implied warranty or condition lasts, so the above limitation may not apply to you. Any supplements or updates to the Software, including without limitation, any (if any) fixes provided to you after the expiration of the ninety-day Limited Warranty period are not covered by any warranty or condition, express, implied or statutory.

10. **CUSTOMER REMEDIES.** Elutions' and its suppliers' entire liability and your exclusive remedy for any breach of the Limited Warranty or for any other breach of this EULA or for any other liability relating to the Software shall be, at Elutions' option from time to time exercised subject to applicable law, (a) return of the amount paid (if any) for the Software, provided that you provide Elutions with a copy of your receipt, or (b) repair or replacement of the Software that does not meet the Limited Warranty and that is returned to Elutions with a copy of your receipt. You will receive the remedy elected by Elutions without charge, except that you are responsible for any expenses you may incur (e.g. cost of shipping the Software to Elutions). This Limited Warranty is void if failure of the Software has resulted from accident, abuse, misapplication, abnormal use or a virus. Any replacement Software will be warranted in normal course of use for the remainder of the original Limited Warranty period or thirty (30) days, whichever is longer.
